## Installation Instructions

The Watts SD2 is a dual check designed for the protection of the water supply. The SD2 prevents the reverse flow of potentially contaminated water back into the potable water supply due to back pressure backflow and is used for continuous or intermittent pressure conditions.

## Installation

Before installing, flush out pipe lines to remove scale and other foreign matter. The valve can be installed horizontally or vertically (flow up or down). Install the valve in the line with the arrow on the valve body pointing in the direction of flow. The valve should be installed such that the valve is accessible for service and maintenance.

#### **NOTICE**

The device should not be installed inside a wall or in a concealed location.

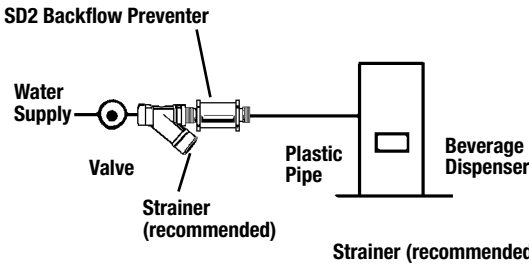
## Applications

The Watts SD2 is recommended for use on dispensing equipment for tea and coffee.

## Maintenance

Annual inspection is required of the backflow preventer to insure proper operation of the device. It is also recommended that a strainer be installed upstream of the backflow preventer.
