Installation, Operation and Maintenance Manual **tekmarNet**® **Gateway 486**





The tekmarNet® Gateway allows remote access to a tekmarNet® HVAC system. Users can view and change settings for each thermostat, including: temperature, heat/cool/auto, fan operation, relative humidity, schedules, and the away scene. In addition, the boiler system temperatures, firing rate, run times, and pump status can be viewed. All system data can be graphed on a chart or exported as a CSV file. Users are informed of errors and warnings through email or text notifications. The 486 includes three alert inputs that can be used to monitor auxiliary equipment.


Installation Location

When choosing the location for the control, consider the following:


- Interior wall.
- Keep dry. Avoid potential leakage onto the control.
- Relative humidity less than 90%. Non-condensing environment.
- No exposure to extreme temperatures beyond 32 to 122°F (0 to 50°C).
- Away from equipment, appliances, or other sources of electrical interference.

- Easy access for wiring, viewing.
- Approximately 5 feet (1.5 m) off the finished floor.
- The maximum length of wire is 500 feet (150 m).
- Strip wire to 3/8" (10 mm) for all terminal connections.
- Use standard 18 AWG wire.
- Ethernet cable maximum length is 328 feet (100 m).
- WiFi maximum distance is 100 feet (30 m) line of sight with no walls. Walls reduce WiFi range.




Press down at the fingertip grips on top of the front cover and pull out and down.




Lift the front cover up and away from the control.





The control can be mounted on a standard DIN rail (sold separately, part M9303). First remove the control from its base and then, using the hooks and spring clip on the back of the control, mount it onto the DIN rail. This will be a popular option for those who prefer to mount the control inside a larger electrical panel.



The wiring can enter the bottom or the back of the enclosure. Knockouts provided in the base allow the wiring to be run in conduit up to the enclosure. The base also has holes that line up with the mounting holes of most common electrical boxes.



Thermostat Addressing

Before connecting the tekmarNet® Gateway 486 to a tekmarNet® system, it is recommended that the system be fully completed, with no tekmarNet® thermostats or setpoint controls being added or removed at a later date. Also, each tekmarNet® thermostat and setpoint control device is automatically assigned a tekmarNet® address when connected to the system. It is recommended that each device be given a manual address. This address should be written down together with the room location for future reference.

The gateway records the address of each tekmarNet® thermostat and setpoint control. The mobile and web app allows the installer to name the room location and building area for each thermostat and setpoint control based upon it's tekmarNet® address.

Wiring

A WARNING



Disconnect all power before opening the control.

To prevent the risk of personal injury and/or death, make sure power is not applied to the product until it is fully installed and ready for final testing. All work must be done with power turned off to the circuit being worked on.

tekmarNet® Bus

The 486 includes four tekmarNet® bus inputs. The tN4 bus inputs allow communication between the 486 and the tekmarNet® system. Each tN4 bus on the tekmarNet® system must be wired to the tN4 bus inputs on the 486. The tN4 bus may be wired before or after the control is powered on and setup.



NOTICE

All available tN4 buses must be wired to the 486 whether or not there are thermostats connected to the bus.

Alert Inputs

The 486 includes three alert inputs, each of which trigger a notification alert. The alert notification message can be customized through the web app.


The alert can be triggered when a switch is closed or powered with 24 V (ac). To select this option, go to the Toolbox menu > Alert Inputs and set to Normally Open.

The alert can also be triggered when a switch is opened or power is removed when the Alert Input is set to Normally Closed.

Examples of how to use the alert inputs to monitor heating equipment problems include:

- · Low water cut off
- Heating oil or propane tank low tank level
- Boiler flame failure lockout
- Loss of equipment power






SD Card

The 486 includes a SD Card. This is used to store historical data for graphing and error history. Removal of the SD card creates an error message and the 486 is unable to record or display historical information.

Ethernet


The 486 may be connected to a router using Ethernet using Category 5e cabling.

The 486 includes a wall plug power supply with a 6 ft. cable.


- Connect the small round end into the power receptacle on the 486.

tekmarNet Menu




- The tekmarNet menu is only available when the 486 is set to **Installer** access level. Go to the Toolbox menu to change.
- The tekmarNet menu displays the number of devices (thermostats, setpoint controls, snow melt controls, boiler controls and timers) connected to each tekmarNet communication bus.
- Touching the Boiler Bus, Bus 1, Bus 2 or Bus 3 button displays a list of all potential 25 devices on the bus.
- A network that includes a boiler control (tN4 System Control) may have up to 4 tekmarNet buses with a maximum of 96 devices.
- A thermostat only network is limited to a single tekmarNet bus and 24 devices.



- This displays the boiler control's information.
- Press "REMOVE" to remove the boiler control from the 486's device list.
- This displays the thermostat's information.
- Press "REMOVE" to remove the thermostat from the 486's device list.




Add a Building





- Press the button to add a new building.
- When you first log in, there will usually be no buildings linked to your account. The exception is when a building administrator shares building access through an email.
- Each tekmarNet Gateway 486 represents a building on the web or mobile app.
- When you Add a Building, your account becomes the building Administrator.
- The building Administrator can share access to other user accounts by sending an invitation email. See Adding Users section.







- Each building requires the following information: building name, address, unit or suite number, state or province, country and ZIP or Postal Code.



Edit or Remove Building






- The Administrator can edit the building information by clicking the building name tab (web) or the pencil 🎤 (mobile).
- The Administrator, Installer and User can remove a building from their account.
- A default building can be selected. Select "Default Building" or "Make this my default location."

Access Levels

Registering a tekmarNet Gateway 486 to your account makes you the building Administrator. The Administrator can share access to a building to other users through an invitation email. Two access levels are available: Installer, and User. Once the invitee creates an account (see Step 5 on pg.15), the invitee account is listed on the Administrator's Users page. For privacy reasons, invitees are unable to view the other accounts with access to the building.








- If you are the Administrator, the menu bar will show a User tab. Press the User tab to view a list of all the users.
- To invite a user to a building, press the *+ button.
- In the tile lower left corner, if the symbol is blue, then the account receives error notifications by email.
- If the **p** symbol is blue, then the account receives error notifications by text message.



• To invite other users, the Administrator enters the invitee's email address, selects either Installer or User access level permissions, and can select to share access to one or more buildings.





- Users can change their first and last names and their country of residence by clicking the Update Profile button.
- Users can request to delete their account by clicking Update Profile button.


Thermostat List





- Each thermostat is listed as a tile, with the thermostat name, temperature and mode (heat, cool, auto, off).
- The information is orange when the HVAC equipment is heating, blue when cooling and gray when off.
- The outdoor air temperature and current local time is displayed in black.
- The scene can be changed from this screen. Select scenes 1 through 8 to change all the thermostat preset temperatures.
- Click on a thermostat tile to view and adjust the thermostat setting.

Thermostat Floor Plan






- To use the floor plan, first click the * button to setup.
- The installer can upload up to three floor plans, one per building level. The floor plan must be a JPEG, PNG, TIF or GIF image file. To create an image file from a PDF, please use a screen capture tool or print screen button on your computer.
- For each thermostat, click the Add Zone button, select the thermostat name and drag it on the floor plan.
- Click the # button to save.



- Once setup, the thermostat name and temperature is listed on the floor plan. Click to adjust the thermostat settings.
- Use the floor plan drop down menu to select the desired building level.


Thermostat Temperature





- The thermostat temperature is shown in the center of the horseshoe slider.
- Adjust the thermostat temperature by adjusting the orange (heating) or blue (cooling) circles.
- The current mode (heat, cool, off, auto) is shown in orange. To change, click on the desired mode.


Thermostat Floor Temperature





• Click the floor heat 🐪 button to adjust the floor heating temperature (only available for radiant floor heating with a floor sensor).












Hydronic System Schematic







Boiler Supply Sensor Open Circuit

Due to an open circuit, the control failed to read the boiler supply sensor. The control no longer controls the boiler, instead, the control read the boiler in the boiler instead, the control read to the control with the sensor is repaired. The control will not operate the boiler contact if the Boil Minimum setting is less than 100°F (38.0°C). Locate and repair the problem as described in the Data Brochure D 070. The error message self clears once the error condition is corrected. Note: On some Universal Reset Controls, the boiler supply sensor can be removed intentionally. In this case, set the boiler sensor location setting to return, then power down for 10 seconds then restart the control.

• Follow the instructions on how to clear the error.

Custom Error Message for Alert Inputs



Alert input configuration is not available on the mobile app

- The tekmarNet Gateway 486 includes three alert inputs to monitor equipment in the boiler room.
- Create a custom notification message that is sent by email or text message when the alert input is activated.
- Set custom Room Hot, Room Cold, Humidity High and Humidity Low alert thresholds. When the temperature or relative humidity crosses the threshold, a notification message is sent by email or text message. The alert clears when the temperature or relative humidity no longer exceeds the threshold.

Troubleshooting FAQ

Issue: I am unable to sign in using my email address.

Answer: Check to see if your mobile phone or computer is connected to the Internet.

I have a WiFi connection but the 486 is not connected to the Cloud.

Answer: Check the router to determine if it has an Internet connection. Also check that the router is not

blocking outbound ports 123 (NTP), 4040 (TLS) or 53 (DNS).

Issue: I am creating a new account and the verification code is not working.

Answer: The verification code must be used within 30 minutes or it expires. Please restart the sign up process.

Issue: I am adding a new building and the 8-digit registration code is not working.

Answer: The registration code must be used within 60 minutes or it expires. Go to the tekmarNet Gateway 486

Internet menu and obtain a new registration code.

Issue: I am unable to view the list of building users.

Answer: Only the administrator may view the list of building users and invite other users.

Issue: I have an administrator account for a building. How do I transfer administrative access level privileges

to another account?

Answer: The tekmarNet Gateway 486 must be deregistered. This requires physical access to the 486. Once

deregistered, the 486 may be registered to the new administrator's account.

Issue: What is the maximum number of buildings that can be registered to an account?

Answer: There is no limitation on the number of buildings that can be registered to a user's account.

Issue: I have added a user but they are not listed on the Users page.

Answer: The invitee must sign up and create an account before they will appear in the Users list.

Issue: I made changes to a Setpoint Control 161 and 162 and the information is not up to date on the web or

mobile app.

Answer: Unlike newer thermostats, the Setpoint Control 161 and 162 do not automatically report changes to the

486. The 486 must find changes by polling the 161 and 162. It may require up to 10 minutes to update

the information.
